## 收集個人資料聲明 Personal Information Collection Statement

1. 凡為子女申請入學之家長，均屬自願性向本校提供有關其子女及家長的個人資料。倘資料不足，本校將無法辦理幼兒之入學申請。  
For all parents applying for admission, the provision of children and parents' personal data is voluntary. However, the school will be unable to handle the applications for admission if parents do not provide sufficient information.
2. 申請表上所填報之個人資料及校方要求的任何補充資料，將用作學生在本校就讀及有關之用途。  
The personal data and additional information provided on the application form will be used for application of school place and other related purposes within the school.
3. 在有必要時，校方需要將申請人之資料向有關機構透露，其中包括(但不限於)教育局、衛生署、社會福利署等部門，以處理學生在學及有關問題之用。  
The school may transfer the personal data of the applicants to the relevant organizations, including but not limited to the Education Bureau, the Department of Health and the Social Welfare Department for the processing of students' school attendance and relevant issues when necessary.
4. 申請人在申請表所提供的個人資料，只會在以下情況才向有關機構透露：  
The personal data provided in the application form will be disclosed to the relevant organizations in the following situations:

The application form for admission will be disposed once the applicants cancel the applications. For students who discontinue their studies and graduates, the application form for admission and relevant data will be disposed once the students leave the school.
